## BEQUESTS TO RYDER-CHESHIRE

In the absence of legal advice the following wording is suggested:

### In relation to a residuary bequest

“I GIVE free of all duties and taxes the residue of my estate (or a specified percentage of the residue of my estate) to

(for Raphael and Klibur Domin homes)

PROVIDED THAT the gift or income derived therefrom be applied exclusively towards the care, maintenance, upkeep, running and/or improvements of its homes, or specific home (Raphael or Klibur Domin)

The receipt of the Secretary, Treasurer or Public Officer from time to time of Ryder-Cheshire Australia Ltd shall be an absolute and sufficient discharge to my executors.”

### In relation to a specific gift

“I GIVE free of all duties and taxes (insert specific gift of asset or money) to

Ryder-Cheshire Australia Ltd, ABN 15362991732  
(for Raphael and Klibur Domin homes)

PROVIDED THAT the gift or income derived therefrom be applied exclusively towards the care, maintenance, upkeep, running and/or improvements of its homes, or specific home (Raphael or Klibur Domin)

The receipt of the Secretary, Treasurer or Public Officer from time to time of Ryder-Cheshire Australia Ltd shall be an absolute and sufficient discharge to my executors.

## HOW TO LEAVE A GIFT IN YOUR WILL

There are two main ways:

- **A residuary bequest** is the simplest way. After providing for loved ones, the remainder of the estate, or a percentage, can be left to Ryder-Cheshire Australia.
- **A specific bequest**, by which you leave a nominated gift of money or assets (ie property or shares).

## LEGAL ADVICE

Making or updating your will need not be complicated or expensive. We recommend that you seek qualified legal advice to help you word your bequest correctly to ensure your executors are able to carry out your wishes.
